Responsibly manage our investments and effectively distribute funds for the long-term benefit of the community we serve.



# **Grants Programme**



TECT restructure = community-focussed Trust which will deliver our Grants Programme. Through our Grants Programme we aim to support people, places and projects making a difference in our community.

Split into 2 approaches – Proactive and Reactive Funding. The Reactive Funds are the ones you would apply to.

We can only fund public benefit entities (registered NFP's) based in the TECT district (Tauranga City Council & WBOP District Council boundaries).

Each organisation can only apply once in any 12 month period regardless of which fund you apply to. Approved grants have a lifespan of 1 year, and will lapse if not claimed within a year.

While we have policy limits that guide how much funding we can grant, the best guide for applicants is to look on our website at the grants we have made over the past two years, and compare yours with other similar organisations, activities, projects or events.

If you have never applied to TECT for funding or have had TECT funding in the past and want to look at funding for other initiatives, please touch base and we are happy to talk through the options with you.

# **Community Facilities**

**Purpose:** Support the build of new facilities or significant upgrade of current facilities. Can also include the purchase of a facility. The facility must have significant community benefit. Two funding rounds each year – May and October. We can receive applications to the fund outside of the two rounds for applications up to \$50k.

Closing Dates of funding rounds: 1st April, 1st September









## **Community Development**

**Purpose:** Support community organisations enhancing the lives of those in our community. People, programmes and purchases. Examples include operating costs, projects, equipment purchases. Monthly funding rounds with a 7-week turnaround time.

Note: we do not fund the repayment of debt, or operating costs for schools or sports clubs.

Closing Dates of Funding Rounds: 1st of each month.









# **Community Events**

**Purpose:** Support community events that are open to the public. Applications are assessed on how whether the event will be enjoyed by a significant number of people in the community and the economic and social benefit the event provides. Monthly funding rounds with a 7-week turnaround time.

Closing Date for Funding Rounds: 1st of each month.
