1.We have been acknowledging all the unpaid/voluntary work and support that happens in our communities during Volunteer Week June 16 – 22nd. What unpaid/voluntary work have you been involved in?

I absolutely support the sentiments in acknowledging the unpaid/voluntary work across Tauranga and Aotearoa. Over the years I have volunteered to deliver pamphlets for various causes, assisted as an usher at a number of both small and large scale community events, and volunteered to guest speak at many gatherings across the country.
